

## Terms and Conditions

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Lobahn Technology Limited (“Lobahn”, “we”, “us”, or “our”), concerning your access to and use of the [www.lobahn.com](http://www.lobahn.com) website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”).

You agree that by accessing the Site, you represent that you are eighteen (18) years of age or older and you have read, understood, and agree to be bound by all of these Terms and Conditions.

If you do not agree with all of these Terms and Conditions, then you are expressly prohibited from using the Site and you must discontinue use immediately.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms and Conditions at any time and for any reason.

We will alert you about any changes by updating the “Last updated” date of these Terms and Conditions, and you waive any right to receive specific notice of each such change. If you object to any change, your sole recourse shall be to immediately terminate your account or cease using the Site.

It is your responsibility to periodically review these Terms and Conditions to stay informed of updates. You will be subject to, and will be deemed to have been made aware of and to have accepted, the changes in any revised Terms and Conditions by your continued use of the Site after the date such revised Terms and Conditions are posted.

The information provided on the Site is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country.

## Definitions

In these Terms and Conditions, the following terms shall have the respective meanings specified below unless the context otherwise requires.

For ease of comprehension, throughout this document the singular includes the plural, and the male includes the female.

“Lobahn” means Lobahn Technology Limited.

“We”, “us” or “our” means Lobahn Technology Limited and its affiliates/associated companies/agents.

“Individual User” means an individual representing himself only who registers on the Site to obtain services offered by us.

“Corporate User” means an individual representing his Employer who registers on the Site to obtain services offered by us on behalf of his Employer.

“Candidate” means an individual professional who uses the Site.

“Employer” means a corporate entity that uses the Site.

“Profile Data” means the employment-related personal data, including Matching Factors, submitted by the Individual User.

“CV” means the document submitted by the Individual User summarising his employment history, professional experience and related background information.

“Image” means the image file submitted by the Individual User.

“Position Listing” means the position description and desired candidate qualities submitted by the Corporate User related to a position opening.

“Matching Factors” means data collected from Individual Users and Corporate Users for the purposes of measuring and reporting the suitability of the User’s background with a career opportunity offered by the Employer.

“Site” means any website or mobile application owned and operated by Lobahn Technology Ltd. and its affiliates/associated companies/agents.

“Users” includes references to generic Users and registered Users.

## Acceptable Site Uses

### Specific Uses – Individual Users

The Individual User agrees that he shall only use the Site for lawful purposes, specifically for seeking employment opportunities and for professional networking. The Individual User agrees to keep his login name and password with care and not to disclose them to any other person. The Individual User is solely responsible for maintaining the confidentiality, safekeeping and security of such login name and password and shall notify us immediately of any unauthorized use of the same.

The Individual User confirms and acknowledges that he discloses his personal data and all other information to the Corporate Users and/or us of his own volition when he applies for available career opportunities posted on or through the Site, and/or when the Individual User uses the Site for purposes of submitting, uploading or posting his Profile Data, CV and/or Image on the Site. By submitting, uploading or posting his Profile Data, CV and/or Image on the Site, the Individual User represents

and warrants that (a) all the information contained therein is truthful and accurate; and he authorizes us to store his Profile Data, CV and/or Image and information or data related thereto in our database ("Database"). The Individual User may send his Profile Data, CV and/or Image and the related information or data directly to any Corporate User who registers on the Site. Alternatively, the Individual User may send his Profile Data, CV and/or Image and the related information or data to us through the Site in reply to any position listing. In such event, the Individual User's Profile Data, CV and/or Image and the related information or data will remain active on the Site and be stored in the Database at his own risk unless and until he chooses to delete them. The Individual User acknowledges and agrees that his Profile Data, CV and/or Image and the related information or data may be accessed by the Corporate Users who have subscribed to our services for the sole purpose of recruiting and assessing the suitability of Individual Users. We also reserve the right to reject, disapprove or edit any part of the Individual User's Profile Data, CV and/or Image and the related information or data as we deem appropriate and to erase any personal data which we reasonably believe are inaccurate, false, illegal, unlawful, infringe copyright / trademark / trade name / trade secret or infringe any other intellectual property rights or invade the privacy of any other person or entity having regard to the purpose (including any directly related purpose) for which the data are or are to be used.

The Individual User acknowledges and agrees to our practice of charging Corporate Users a fee to access to the Site, the Database and/or the Individual Users' Profile Data, CV and/or Image, details and the related information or data for the sole purpose of recruiting and assessing the suitability of Individual Users and subject to the terms herein. The Individual User also recognizes that he shall have no claim to any such fee received by us.

We will not release the Individual User's personal data to any Corporate User without his permission unless required by any authorized institution or obliged under prevailing laws and regulations. The Individual User acknowledges and agrees that we can, if he so authorizes, release his Profile Data, CV and/or Image to Corporate Users through the use of our search engine or any other means for the sole purpose of enabling Corporate Users to recruit and assess the suitability of Individual Users in relation to any position opening.

You acknowledge, understand and agree that no company, including us, can fully eliminate security risks connected to the handling of data on the Internet. Although we shall use our reasonable endeavours to restrict access to the Database only to Registered Users and our personnel, we cannot and do not guarantee that other parties will not, without our consent, gain access to the Database. The Individual User may disable searching or viewing of his Profile or CV by Corporate Users at any time. However, the Individual User acknowledges that Corporate Users and other parties who have otherwise gained access to the Database may have retained a copy of the Individual User's Profile Data, CV and/or Image. To the furthest extent permissible by applicable law, the Individual User acknowledges and agrees that we shall not be responsible for the retention, use or privacy of his Profile, CV or Image in

these instances, or for the use or privacy of his Profile Data, CV and/or Image by any of such parties while the Profile Data, CV and/or Image is in the Database. To the furthest extent permissible by applicable law, we will not be responsible or held liable in any way if any Corporate User or other User, in breach of the Terms and Conditions, whether in Hong Kong or elsewhere, uses the Individual User's personal data, information or materials for any purpose other than for recruiting potential employees. The Individual User accepts that all personal data, information or materials given to a Corporate User or other Users, or submitted on or through the Site, are given entirely at his own risk.

#### Specific Uses – Corporate Users

The Corporate User agrees that he shall only use the Site for lawful purposes and for promoting any position-related activities.

Upon payment of the service fee to us or upon acceptance of any free trial promotion offer, the Corporate User will be entitled to use the Site to post position listings for a predetermined period following agreement of the predetermined service, save and except for any free trial promotion offer. Subject to the conditions or requirements from time to time stipulated by us regarding the access to Individual Users' information or data, the Corporate User agrees that all information or data obtained as a result of such access shall only be used for the sole purpose of recruiting and assessing the suitability of Individual Users and that such information or data shall not be disclosed to any other parties without the prior consent of the Individual User concerned. The Corporate User acknowledges and agrees that it shall disregard any information or data received from an Individual User which is irrelevant to recruiting and assessing the suitability of Individual Users.

The Corporate User shall be solely responsible for the contents of and materials contained in its position listing posted on the Site. We reserve the right to remove or edit, or require the removal or amendment of, any position listing as we deem appropriate, or to terminate or suspend the Corporate User's access and use of the Site and/or services offered on or through the Site, in accordance with the agreement for such services between the Corporate User and us.

From time to time Lobahn may invest in marketing campaigns to promote Corporate User brands (including but not limited to Google ads, Yahoo ads, Baidu ads, Facebook ads, Twitter ads, ad networks, Demand Side Platforms, Real Time Bidding, retargeting and other programmatic buying strategies) and acknowledge that such promotion may be outside the domain of Lobahn or its subsidiaries / affiliates.

We also reserves the right to change the service fee or institute new charges or fees, from time to time, as we deem appropriate. In the event that any Corporate User fails to pay the service fee or any other fees or charges due to us, we reserve the right to suspend or terminate the Corporate User's position listing and/or right to access the Site, without prejudice to all other rights and remedies available to us.

#### Prohibited Uses – All Users

Users agree(s) that: -

Individual Users shall not post any incomplete, false or inaccurate Profile, Image or CV-related information or data on the Site.

Individual Users shall not respond to any position listing for any reason other than to apply for the position advertised, and Corporate Users shall not respond to any Individual User other than in connection with his application for a position.

All Users shall not use the Site in any manner that infringes the intellectual property rights or proprietary rights of others.

All Users shall not print, download, duplicate, transmit or otherwise copy, reproduce, re-distribute, republish or use any personally identifiable information about other Users save and except that the Corporate Users may use the Individual Users' Profile Data, CV and/or Image and the related information or data accessed by the Corporate User pursuant to the Acceptable Site Uses described above.

All unsolicited communications of any type to Users are strictly prohibited.

All Users shall not delete, revise or remove any material posted by any other person or entity.

All Users are prohibited from violating or attempting to violate the security of the Site including, without limitation, accessing data not intended for them or logging into a server or account which they are not authorized to access, attempting to probe, scan or test the vulnerability of a system or network or attempting to breach security or authentication measures without proper authorization, attempting to interfere with service to any User, host or network or sending unsolicited e-mail, including promotions and/or position listings for products or services. Any dispute, controversy or claim arising out of or relating to the Terms and Conditions including the validity, invalidity, breach or termination thereof, shall be settled in the first instance by mediation. If mediation proves unsuccessful, then arbitration shall follow in accordance with the UNCITRAL Arbitration Rules as at present in force and as may be amended by the rest of this Clause:

The appointing authority shall be Hong Kong International Arbitration Centre ("HKIAC"). The place of arbitration shall be in Hong Kong at HKIAC.

There shall be only one arbitrator.

The language to be used in the arbitral proceedings shall be English.

In the event of any breach of the Terms and Conditions by a party, the other party shall be entitled to remedies in law and equity as determined by arbitration.

#### Force Majeure

Without prejudice to the provisions of these Terms and Conditions limiting or disclaiming liability, we are not liable for any delay or failure in performance resulting directly or indirectly from causes beyond its reasonable control, including,

without limitation, failure of the internet, power failure, failure of computer, telecommunication or other equipment, strikes, labour disputes, riots, public health emergencies, insurrections, civil disturbances, shortage of labor or materials, fires, floods, storms, explosions, acts of God, war, governmental actions, orders of domestic or foreign courts and non-performance of third parties.

#### Entire Agreement

The Terms and Conditions and the Privacy Statement shall constitute the entire agreement between you and us relating to your use of the Site, and shall replace and supersede all other communications (written or oral), discussions, letters and contracts relating to the subject matters hereof.

#### Severability

The provisions of the Terms and Conditions shall be enforceable independently of each other and the validity of each provision shall not be affected if any of the others is invalid.
